





- 2. (T) Pursuant to the Order dated April 17, 2019, of the Illinois Commerce Commission in Docket 19-0207, Henry County Telephone Company shall impose a (T) supplemental charge of 2 cents per month per line for all Illinois (R) telecommunications carriers, including wireless carriers (other than prepaid wireless (R) carriers) and VoIP residential subscriber lines, a charge of 0.4 cents per VoIP (R) business subscriber line, a charge of 0.4 cents for all Centrex lines, and a charge of 10 cents per PBX trunk. Charges for services provisioned by T-1 lines and other (R) advanced services shall mirror Henry County Telephone Company's application of 9-1-1 charges. The assessment on prepaid wireless transactions is established at (R) .07% of the prepaid retail transaction, to be implemented by the Illinois Department of Revenue. These charges shall be effective with bills rendered on or after July 1, 2019 or at the beginning of the first cycle after July 1, 2019. (T)
